Project Architecture

Architectural Services, Building Envelope Restoration at Pomonok Houses, Queens, NY, for NYCHA (New York City Housing Authority). The development consists of 35 residential buildings originally built in 1952. The buildings vary in size (6,500 SF to 20,000 SF) and height (three to seven stories). The scope of work included the preparation of field bulletins and the architectural & engineering design for roof replacements, window replacements, brick repairs, including addressing FISP findings for all 35 buildings. The water tank and pump system were also replaced. In addition to asbestos/lead abatement, specifications and estimates, the scope of work included assisting NYCHA in bid and award, and construction phases.

Field Surveyor

Historic Preservation and Use Conversion at 90 West Street, NYC. Designed by Architect Cass Gilbert in 1907, this building is considered the 'Little Woolworth' because it precedes the architect's masterpiece. Located at the southwest corner of 'Ground Zero', the landmark was severely damaged on September 11, 2001. As member of a team of architects and engineers, Ms. Kennedy helped the Clients meet their goal of restoring 90 West Street to its original glory and converting the commercial property to residential rental units. Exterior work included the replacement in kind of almost 8,000 terra cotta pieces and approximately 80,000 bricks, all custom manufactured. Work also included the replacement of the copper mansard roof, the replacement of all windows and a thorough cleaning of the existing terra cotta and granite façade.
